

## **Cross-border Quality Assurance Framework**

### International Joint Accreditation among Japan, Taiwan, and Thailand PROJECT BACKGROUND

As the mobility of students and faculty increases with globalization and ICT-based education advances worldwide, there is an even greater need for international recognition of the quality education being provided. As well. QA agencies are required to conduct highly reliable accreditation activities.

The iJAS (International Joint Accreditation Standards ) project is cross-border quality assurance framework launched by JUAA and TWAEA in 2018 to contribute to the promotion of internationalization of universities.



The iJAS project is developing with the participation of ONESQA in 2021, with universities in Japan, Thailand, and Taiwan as its assessment targets. By collaborating with overseas QA agencies to develop and jointly evaluate an internationally standardized evaluation criteria, this project aims to improve the quality of higher education in each country and provide a robust platform to further progress toward the next global era. The distinctive feature of the iJAS project is that the assessment focuses on a university's internal quality assurance system.

In addition, the iJAS project will be extended not only to universities in Japan, Taiwan, and Thailand, but also to higher education institutions in the Asian region in the near future, actively supporting quality enhancement of universities in order to improve the learning outcomes of students studying in the Asian

### **Japan University Accreditation Association**

JUAA was established in 1947 by 46 universities, taking several U.S. accreditation agencies as a model, and certified as the Certified and Evaluation and Accreditation Agency for universities by the Ministry of Education, Culture, Sports, Science and Technology (MEXT) in 2004. JUAA is a voluntary organization of higher education institutions which mission is "to promote to qualitative improvement of higher education institutions in Japan through the voluntary efforts and mutual assistance of member institutions and to contribute to international cooperation such as educational and research activities in higher education institutions." JUAA conducts certified evaluation and accreditation for institutions and professional graduate schools, and program accreditation for schools of veterinary medicine and dentistry.

In addition, JUAA prioritizes survey and research in order to develop more advance projects for quality assurance and quality improvement of higher education institutions. JUAA Research Institute for Quality Assurance of Higher Education (RIQAHE), established in 2018, carries out several projects and publishes their results, as well as regularly organizes open seminars and conferences to provide a platform for university stakeholders to share their views and opinions. ### **ACCREDITATION SYSTEM**

The "International Joint Accreditation Committee" shall be set up under the iurisdiction of JUAA. TWAEA and ONESQA. Then, "Review Team" shall be formed for each applicant institution based on their nationalities, features and attributes under the Committee. The review team is composed of 5 members. Senior professors with administrative experience or senior administrative staff related to evaluation/quality assurance activity, or top industry executives should in principle be invited to serve on the review team. Of the five evaluators, one shall include the applicant institution's local evaluator, and the remaining four shall be selected from two other countries each.



### **APPLICATION REQUIREMENTS**

Eligibility to apply for the iJAS project is open to any college or university that received accreditation or evaluated by TWAEA, JUAA, or ONESQA.

### STANDARDS FOR INTERNATIONAL JOINT ACCREDITATION



### **ACCREDITATION PROCESS**

The major flow of the accreditation is shown in the figure below.

The review team will provide a "Request for Clarification List" 5 weeks before the on-site review. The institution should provide its response to the items in the "Request for Clarification List" 2 weeks before the on-site review. Before the finalization of the accreditation results, there is also an opportunity for the institution to submit comments on the draft accreditation results.

Accreditation results can be "accredited" or "not accredited" in accordance with iJAS standards. The accreditation certification will be issued in 4 languages (Chinese, Japanese, Thai, and English). The results are also published on the website and in relevant public documents.

The information can also be disseminated on suitable occasions.

## MESSAGE FROM ACCREDITED UNIVERSITIES



Dr. Norihiko Suzuki Former President Akita International University (Japan)

Despite the long-standing call for the internationalization of higher education, finding a common direction for developing specific strategies has not been easy. That said, international collaboration among quality assurance agencies for university education is, at present, the most fundamental framework for international quality assurance in higher education as it involves the tasks of verifying and assuring the quality of higher education in accordance with a mutual set of standards. The Japan University Accreditation Association (JUAA) and its Taiwanese counterpart, the Taiwan Assessment and Evaluation Association (TWAEA), together developed the International Joint Accreditation Standards (iJAS) as an international collaborative framework for evaluation and accreditation of Japanese and Taiwanese university education. The first institutions to undergo an accreditation review under this project were Akita International University (AIU) in Japan and Chia Nan University of Pharmacy and Science (CNU) in Taiwan. At the review session that essentially marks the first step of internationalization activities by a Japanese quality assurance agency for higher education, an assessment team made up of Japanese and Taiwanese evaluators performed a rigorous, day-long assessment covering six accreditation standards and concluded that the two institutions meet international standards in both education content and levels. As a first-of-its-kind experience even for AIU teachers and staff who are used to international exchanges, anxiety intensified during the many hours spent preparing for the review. We expect that undergoing an accreditation process will be a requisite for other Japanese universities in the future. With overseas institutions increasingly demanding quality assurance in education from their potential international collaboration partners, we now live in a time when by what quality assurance agency a university is accredited has become a serious question.

The latest iJAS accreditation has allowed us to take a big first step forward towards our goal of increasing the international recognition of our university.
